2. At least 75% of the beneficiaries must be black South Africans. Blacks include all people who were previously disadvantaged as defined by the Broad Based Economic Empowerment Act of 2003.
3. Beneficiaries must be situated in the areas of Sea Vista and Umzamowethu. Consideration will be given to beneficiaries situated within a 50km radius of Kouga Wind Farm
4. All organisations applying for assistance must be registered and audited on an annual basis. Proof of this in the form of relevant documentation will be required.
5. Activities of the organisation should fall within the following key areas:
  - a. Education
  - b. Skills Development
  - c. Healthcare
  - d. Recreation
